- 1. Payment amount due and due date.
- 2. Service address and meter information including usage detail.
- 3. The usage history graph compares your monthly usage to the same time last year.
- 4. The detail of charges will provide your account number and a detailed list of charges for the current billing period.
- 5. Your account number and total amount due. To ensure proper credit. please detach and return the bottom portion with your payment.
- 6. Bar code for scanning your account number at our kiosk locations in Marion and North Liberty.
