Connect With Us At The Annual Meeting

Join us online for the annual meeting on Thursday, September 21st. The Zoom meeting will begin at 9:00 am. Instructions for online participation are coming in next month's newsletter and on our website.

Our annual meeting is an opportunity for you to exercise one of the greatest benefits of being a member of an electric co-op ~ voting for the board of directors. This year, members will vote on two changes to our articles of incorporation and elect three board members. The proposed changes are to Article IX, Directors; Section 3. The board has recommended a wording change to clarify board eligibility. The other is Article IX, Nominations; Section 5. The board has recommended increasing the number of days to appoint the nominating committee from 120 to 180 days.

The proposed amendments will be placed on this year's ballot. **Please note that a** member voting for directors but not voting on the Article changes counts as a NO vote for the Article changes. You can review the proposed article changes as they will appear on the ballot at www.linncountyrec.com.

Survey and Ballot Systems (SBS) will administer our voting and ballot validation process. Members can vote online, through our Smarthub app, or by mail ballot. Voting will be available from August 18th at 8:00 am through September 18th at midnight. All members may vote regardless of the district in which they reside. Members who vote online or by mail ballot are entered into a drawing for a bill credit. Learn more about our voting options below.

What strengths would you bring to our board if elected? "I never stop learning and am always striving to improve myself, my career, my community, and my life. Short term/Long term goals: "In the long and short term, I am eager to work toward delivering Linn County REC members the most reliable and environmentally friendly energy, at the lowest possible cost. If elected, I would hope to quickly get up to speed with the other board members to better understand the most pressing issues facing Linn County REC today. What do you feel is the biggest issue facing the co-op today? However, the potential for cyber-attacks is likely the biggest issue as cyber-criminals have proven their capability to hold energy companies and their members/users hostage."

What strengths would you bring to our board if re-elected?

"Knowledge of Federal, State, and MISO regulations and laws, and the utility grid, especially, as it pertains to Eastern Iowa.

Active involvement with economic development, along with being a life-long resident of the area with understanding of the history and growth of Eastern Iowa."

Short term/Long term goals: "To assist in making decisions that will maximize productivity and minimize expenses given the current regulatory and rate structure system in the state and the Country. To be proactive in controlling electricity costs, implementing use of alternative forms of energy (wind, solar and landfill gas) and costs associated with delivery in order to give the members the best rates and service possible in a constantly changing environment of Federal, State and Local regulation. Ultimately, I would like to see that rates to Linn County REC members remain among the lowest while still providing the consistent quality service we deserve. Given this we have to plan not only for today but also for resource (power) adequacy 25+ years from now."

What do you feel is the biggest issue facing the co-op today? "The biggest issue facing Linn County REC or any utility is providing the best service and delivery at the lowest price. This is what customers want and deserve. Baseload, dispatchable energy to meet the needs of our members must be available 24 hours a day, 7 days a week in an amount to provide safe, reliable power. To do this requires constant vigilance of policies, procedures and providers with no room for complacency."

What strengths would you bring to our board if elected? "My

My Masters of Public Administration (MPA) and MS in Guidance and Counseling Degrees provide an educational background for both understanding the functions of Public Services and dynamics of working with groups and individuals. My BA in Criminal Justice and experience as a Security Police officer provide a background in resources protection and information security that will be valuable to any organization. My experience in working with groups to identify and prioritize goals and objectives will help me to quickly adapt to the purpose and functions of the Board."

During recent years more cyber attacks have been launched against both public and private entities. Through ever changing technology, private information has become more vulnerable to attacks by individuals with nefarious intent. Terrorism against public utilities has also become a greater threat from those who wish to disrupt services to people and critical resources."

What strengths would you bring to our board if elected? "Available to assist with research for future REC initiatives. I also ask good questions."

Short term/Long term goals: "A short-term goal is to support REC's use of smart technologies to reduce cost to consumers. A long-term goal is to look at replacing REC's fleet with EV vehicles."

What do you feel is the biggest issue facing the co-op today? "People transitioning to EV vehicles to support government initiatives to reduce carbon emissions will lead to an increased demand for energy. As REC partners with energy providers, they should look to those investing in renewable energies like solar and wind. This will help support emissions guidelines by reducing fossil-fuel consumption. Other green technologies should include reducing the use of energy through smart technologies. This will maximize the utilization of energy. REC is currently providing information to their consumers to achieve these goals. They should be encouraged to continue this initiative as new products emerge."

What strengths would you bring to our board if re-elected? "I have a variety of management experiences, including nine years as a member of the Linn County REC Board of Directors. This includes strategic planning, budgeting, personnel management and project management. I have a strong work ethic and have devoted the time needed to be an effective Board member. I have completed over 25 NRECA classes and training to improve my knowledge of cooperatives. I have my Credentialed Cooperative Director Certificate (CCD), my Board Leadership Certificate (BLC) and my Director Gold Credential. I have used this education to try to

Short term/Long term goals: "The Board updated our strategic plan for Linn County REC in 2020 and will need to review and update the plan in the near future. This will outline the general direction for our cooperative for the next 3 to 4 years. We continue to have significant growth in the North Liberty area and the Board continues to address those needs. Cyber security is an ongoing and increasing issue for Linn County REC. Long term, we need to continue to provide safe, reliable, affordable, modern and secure energy for our members. Linn County REC has the largest number of members of all the electrical cooperatives in Iowa, with almost 33,000 members. We are steadily growing. We have a stable and sound financial portfolio. Linn County REC has very good management and staff. It is the Board's responsibility to oversee our CEO to make sure we continue with that effective management. We are continually striving to make improvements."

What do you feel is the biggest issue facing the co-op today? "There are two issues that the Board discusses on a regular basis. These issues are cyber security and the issues that develop because of our continual growth. The recent negotiation of a wholesale power contract should assist in stabilizing our power supply for the next few decades. This is dependent on our power supplier, CIPCO, in maintaining a balanced power portfolio."



SLOPPY JOE COWBOY BEANS

1 lb ground beef

2 Tbsp minced onion flakes

1 (1.31-oz) packet sloppy joe seasoning

1 (15-oz) can tomato sauce

½ tsp white vinegar

1/4 cup brown sugar

½ cup chopped cooked bacon, (about ½ a pound cooked)

3 (15-oz) cans pork & beans in tomato sauce, undrained
