2022 YEAR IN REVIEW A Message To Our Members

Financials

Operating revenue for 2022 was \$61.1 million, or 7% higher than in 2021. More kilowatt-hour sales and higher power costs from our power supplier were the primary drivers of more revenue. Power costs were \$35.2 million, or 12% higher than in 2021. In 2022, the natural gas prices at the U.S. natural gas benchmark (Henry Hub in Louisiana) increased an average of 53% from 2021, which increased market power prices. Increases in operations and maintenance costs and depreciation expenses were the primary factors reducing the Cooperative's operating margin after fixed charges to \$2.6 million in 2022 vs. \$3.5 million in 2021. Operating margins were still adequate to meet our lender requirements.

Capital Credits

Our net margin was down due to less patronage allocated from Central Iowa Power Cooperative (CIPCO), our power supplier. The Board of Directors elected to return \$250,000 in capital credits to current members. Those who are current members will see a credit on their September bill.

Growth & Investment

New services installed were 961 in 2022, down from the prior year. Total Linn County REC services at the end of 2022 were 33,090. The Cooperative continues investing in the system to address development, new services, and reliability. In 2022, 94% of the Cooperative's capital expenditures were for line construction, new services, and substation enhancements. The remainder was spent on equipment. The total capital spent in 2022 was \$10.2 million.

Looking Ahead

In 2023, we have noticed a few factors impacting the Cooperative so far:

• Higher interest rates are impacting new housing starts, resulting in lower new services.





- Lower natural gas prices have helped stabilize power costs. The weather has been milder, leading to slightly fewer sales than we budgeted.
- Some members are taking advantage of the new time-ofday rate and are shifting energy usage to overnight hours (i.e., EV charging), which helps the entire membership.

Results to date are very positive, with the Cooperative in good financial shape. We will continue to keep members informed about the co-op through our communications channels, including the member newsletter, Facebook, website, and email. As a locally owned cooperative, we strive to keep our members informed and educated.
